

# Terms & Conditions



## 'PICK THE JOKER'

### 1. PROMOTION TYPE

- 1.1. Raffle sub promotion

### 2. PROMOTION DAYS / TIME

- 2.1. The promotion will run every Friday until further notice
- 2.2. The promotion will be drawn at the conclusion of Friday Night Raffles
- 2.3. Friday night Raffle tickets go on sale from 4:30pm and the draw commences from 6:30pm

### 3. ENTRY METHOD

- 3.1. A ticket for Pick the Joker is gained for every \$10 spent on Friday night raffle tickets

### 4. HOW TO WIN

- 4.1. One Pick the Joker ticket will be received for every \$10 spent on Raffle tickets
- 4.2. Members/Visitors write their full name on the back of the ticket and place the ticket in the Pick the Joker barrel
- 4.3. A ticket will be drawn and announced at the end of the meat raffle. The winner must be present and will have 2 minutes to present themselves before a redraw will occur
- 4.4. The member/visitor will have the opportunity to select and reveal one card from the card selection on the board of 49 cards
- 4.5. If the Joker is selected the winner will receive the jackpot amount. See prize schedule below
- 4.6. If the Joker is not selected a consolation prize will be awarded. See prize schedule below
