

Terms & Conditions



‘UNDERS OR OVERS’

1. PROMOTION TYPE

- 1.1. Gaming promotion

2. PROMOTION DAYS / TIME

- 2.1. The promotion commences on Friday January 4 2019 and will run every Friday until further notice. The promotion will begin at 8.00pm and conclude at 10.00pm each Friday
- 2.2. Entries will be generated from 7.45pm –10.00pm on the day of the promotion.

3. ENTRY METHOD

- 3.1. Members visit the gaming lounge on the above-mentioned days, during the above time periods and insert their membership card in the gaming machine card reader whilst playing. For every \$2 turnover on a gaming machine, an entry will be automatically generated into the virtual ticket barrel.

4. HOW TO WIN

- 4.1. To have a chance to win any prize, members must be present in the gaming room at the time their name is drawn from the kiosk virtual barrel draw and approach the promotion host within 1 minute. After this time has lapsed, a redraw will occur.
- 4.2. One member will be drawn from the barrel every 15 minutes from 8.00pm during the promotion times to play the daily game show. A total of nine (9) members will be drawn each day the promotion is run.
- 4.3. Winners will automatically receive \$5 in cash and can choose to spin the wheel or not.
- 4.4. If the winner chooses to continue to participate, they have to pick whether or not they think the wheel will end on a number higher or lower than the start value.
- 4.5. The player then spins the wheel which MUST complete at least 3 full spins to qualify as a turn. If the player is correct they win another \$5 in cash which will continue to accumulate.
- 4.6. If the player wins, they can choose to either take their winnings or continue to play and spin again following the instructions above. The wheel will stay on the number it lands on from the previous turn during the process of the game. Each winning spin will accumulate the cash prize amount until the player decided to no longer spin and take their prize or until they lose.
- 4.7. On the third spin of the wheel the player will have the opportunity to double their money or lose their money.
- 4.8. If the player does not win they will still walk away with their original \$5 in cash.

5. PRIZE SCHEDULE

- 5.1. All nine members will have a chance to play ‘Unders or Overs’ to win a selection of cash prizes.
- 5.2. The total maximum prize pool awarded each day is \$270 worth of cash prizes.
- 5.3. Prizes are not transferrable or exchangeable.
- 5.4. The prize consists of the following value:

The following prize pool will apply for each Draw:

- Spin 1. If the Winner fails to choose correctly at the first spin the game ends and they will win \$5 cash. If they guess correctly, they can choose to take \$10 or proceed to Spin 2.
- Spin 2. If the Winner fails to choose correctly at the second spin the game ends and they will win \$5 cash. If they guess correctly, they can choose to take \$15 or proceed to Spin 3.
- Spin 3. Chance to double their winnings to \$30 cash. If the Winner fails to choose correctly at the third spin the game ends and they will win \$5 cash. If they guess correctly, the game will end and the player wins \$30 in cash.

6. GENERAL CONDITIONS

- 6.2. A member can be drawn out a maximum of nine times each promotional period.
